Prime Minister Narendra Modi tells in his *Mann Ki Baat* that agriculture reforms are empowering farmers and urged people to contribute towards developing their alma mater in the best possible way

AGRICULTURE REFORMS : Reforms have not only served to unshackle farmers but also given them new rights and opportunities. These new rights have begun to ameliorate woes of farmers. Jitendra Bhoji, a farmer from Dhule district in Maharashtra, made use of the recently promulgated farm laws. Bhoji sold his corn produce for approximately Rs 3.32 Lakh and received an advance. It had been decided that the outstanding amount would be cleared in fifteen days. However, later such circumstances developed that he did not receive the remainder for four months. The new farm laws passed in September came to his aid. Under this law, it was decided that all dues of farmers should be cleared within three days of procurement, failing which the farmer can lodge a complaint.

DEVI ANNAPURNA'S IDOL: Every Indian will be proud to know that a very old idol of Devi Annapurna is returning to India from Canada. It was stolen from a temple of Varanasi and smuggled out of the country somewhere around 1913. Mata Annapoorna has a very special relationship with Kashi.

VIRTUAL GALLERIES: Lots of museums and libraries are working to make their collections fully digital. In Delhi, National Museum is doing a fabulous job by working on introducing around ten virtual galleries.

We are eagerly waiting for your feedback and suggestions.



EXPANSION OF UMANG

The UMANG (Unified Mobile Application for New Age Governance) App can now be availed by Indian students, tourists and overseas Indians. It can now be downloaded in US, UK, Canada, Australia, UAE, the Netherlands, Singapore and New Zealand as well. Launched in November 2017 with 163 features, the App provides an access to various Government services and bill payments. It offers over 860



services of Government including EPF, PAN, DigiLocker, gas booking in 27 states and nearly 1180 services for bill and challan payments. This includes 373 services from 88 departments, 487 services from 101 departments. So far, 3.75 Crore people have downloaded this App in India. Facility of this App will be introduced in other countries as well. Their number is constantly increasing.



Antiques stolen from a temple in TN retrieved from London

Relentless efforts made by the Government in preserving country's ancient artefacts met with success when 13th century bronze idols of Lord Rama, Lakshmana and Goddess Sita have been handed over to the Idol Wing, Government of Tamil Nadu on November 18, 2020 in New Delhi. The idols stolen in 1978 from Sri Rajagopal Vishnu Temple were returned by the London Metropolitan Police to the Indian High Commission, UK on September 15, 2020. The temple was built during the Vijayanagara period at Anandamangalam in Nagapattinam district of Tamil Nadu.

Raise in scholarship for SC students

With an increase of Rs 2 Lakh per annum from Rs 6 Lakh to Rs 8 Lakh in National Overseas Scholarship Scheme for Scheduled Castes students, the Government has shown its resolve towards the growth of weaker and under privileged sections of the society. The announcement, effective from the selection year 2020-21, is for students securing admission in globally higher ranking institutions. The minimum qualifying marks have also been increased from 55 per cent to 60 per cent.

Over 50,000 Ayushman Bharat Health & Wellness Centres functional now

Pradhan Mantri Jan Arogya-Ayushman Bharat Yojana, launched to provide free treatment to around 50 Crore poor people has achieved another milestone. Now, there are more than 50,000 operational Ayushman Bharat - Health and Wellness Centres (AB-HWCs). Around 1.5 Lakh AB-HWCs will be established by December, 2022. The AB-HWCs are spread across 678 districts, and include 27,890 Sub Health Centres, 18,536 Primary Health Centres and 3,599 Urban Primary Health Centres.

Subsidy on transportation under Operation Greens TOP to TOTAL



The Ministry of Food Processing Industries (MoFPI) has brought out various schemes for the development of farmers. Operation Greens Scheme TOP to TOTAL is one such scheme which provides 50 per cent subsidy on transport and storage of notified fruits and vegetables. The subsidy would also be available under Kisan Rail Scheme. Similarly, subsidy is now made available for air transportation for fruits, vegetables from North-Eastern, Himalayan States.

Banks reaching out street vendors to help them under PM SVANidhi

PM SVANidhi Scheme meant for street vendors is yielding good results providing benefits to them. Till date, 7,88,438 loans were disbursed proving to be a boon for street vendors. Out of 27,33,497 loan applications received so far, 14,34,436 applications were approved. Vendors who had left for their native places due to COVID-19 lock down are eligible for the loan on their return.



“India Climate Change Knowledge Portal” launched

To strengthen Government’s resolve towards environment protection, Ministry of Environment, Forest and Climate Change has launched the “India Climate Change Knowledge Portal”. It will be a “single point information resource,” which provides information on various initiatives taken by various ministries enabling users to access updated status on these initiatives. Major components included India’s Climate Profile, National Policy Framework, India’s NDC goals, Adaptation Actions, Mitigation Actions, Bilateral and Multilateral Cooperation, International Climate Negotiations, Reports & Publications. Expressing happiness over the web portal launch, Union Minister of Environment, Forest and Climate Change Prakash Javadekar said that the country has practically achieved its Pre-2020 Climate Action targets. Pragati reviews project worth Rs 1.41 Lakh Crore

Pragati, the monthly e-governance initiative launched by Prime Minister Narendra Modi to bring Union Ministries and relevant State Governments on the same page, throws light on his working style. In its 33rd meeting on November 25, 2020, projects worth Rs 1.41 Lakh Crore spanning 10 States and Union Territories were reviewed. The projects which were taken up were from Ministry of Railways, Ministry of Road Transport and



Highways (MoRTH) and Power Ministry. These projects were in Odisha, Maharashtra, Karnataka, Uttar Pradesh, J&K, Gujarat, Haryana, Madhya Pradesh, Rajasthan and Dadra and Nagar Haveli. The Prime Minister asked the concerned Secretaries of the Union Government and Chief Secretaries of the State Governments to ensure that they complete the work before time.

Grievances related to COVID-19 and to the PM Awas Yojana were also taken up. ■



India enters decisive phase of fight against COVID-19

Coronavirus infection is continuing to affect lives of people worldwide. The year 2020 started with pandemic reaching various countries and parts of the world. This brought the lives to a standstill worldwide. However, the end of the year has given a hope for an indigenous vaccine for the Coronavirus infection. Prime Minister Narendra Modi reviewed the progress of the vaccine in different parts of the country. He visited vaccine facilities in Ahmedabad, Hyderabad and Pune in November

India produces 60 per cent of the world's vaccines. So, it is obvious that in the fight against Coronavirus, India is a big hope for the rest of world. Around 212 vaccines are being developed to fight the Coronavirus infection across the globe. World Health Organization's (WHO) says, of these 212 candidate vaccines, 48 are in the clinical evaluation stage and 164 are in the pre-clinical evaluation stage.

Among those in the clinical evaluation stage, 11 are in phase-3 of clinical trials. There are three other vaccines in phase-2 of clinical trials. At least 13 are in phase-1/2, and 21 in phase-1. Six vaccines have been given the Emergency Use Authorisation.

In India, Zydus Biotech Park in Ahmadabad, Bharat Biotech in Hyderabad and Serum Institute of India in Pune are developing the COVID-19 vaccines. Under the AatmaNirbhar Bharat 3.0 package, Rs 900 Crore were earmarked for research and development activities related to COVID-19 vaccine. On November 28, 2020, the Prime Minister visited the Zydus Biotech Park in Ahmedabad, Bharat Biotech in Hyderabad and Serum Institute of India (SII) in Pune. After the Prime Minister's visit, Chief Executive Officer of SII Adar Poonawalla said that he was amazed by the Prime Minister's knowledge about vaccines and vaccine production.

MEETING WITH CMs OF EIGHT STATES OVER VACCINE DISTRIBUTION

- Chief Ministers of eight states were asked to review status, preparedness of COVID-19 response and management. They assured that the way focus in the fight against COVID-19 has been on saving every life, the priority will be to ensure that vaccine reaches everyone
- The meeting, held via video conferencing, had chief ministers of Haryana, Delhi, Chhattisgarh, Kerala, Maharashtra, Rajasthan, Gujarat and West Bengal
- This was the Prime Minister's 11th meeting with the Chief Ministers on the issue
- The Prime Minister noted that priority of vaccination is being decided in consultation with the States
- Requirements of additional cold chain storages have also been discussed with the States
- He asked the Chief Ministers to ensure regular monitoring of State Level Steering Committee and State and District Level Task



Force to ensure better results

- So far, India has more than 28,000 cold chain points and is working to increase the number
- To track each vaccine, a digital platform is being prepared and tested. This will track each and every step of the vaccine from its exit from the company till it reaches the people
- Priority for vaccination will be given to healthcare, frontline and all those workers who are at the risk of infection
- Procurement of the syringe is also in the last stage

Covishield

Early results found to be effective up to 90%

- The Serum Institute of India, along with Oxford University and AstraZeneca, has created the vaccine (Covishield). Serum said an application for emergency use would be made within two weeks in India.



Covaxin

Phase-3 trials of Covaxin have started in about 25 locations.

- It has been developed by Bharat Biotech of Hyderabad in association with the National Institute of Virology and the Indian Council of Medical Research. The target is to launch the vaccine by the first quarter of 2021

- According to Principal Scientific Advisor K. Vijayaraghavan, the National Vaccine Committee headed by Dr. VK Paul has prepared a blueprint that who will be the first to be vaccinated
- In a meeting of the Ministry of Science and The Confederation of Indian Industry, he informed that 31 Crore people have been identified to be vaccinated between March and May
- Vijayaraghavan said, 'The vaccine will be given first to One crore health workers, police force of states and central government, armed jawans, home guards, 26 crore members of priority group above 50 years and high risk group below 50 year

Former Prime Minister Atal Bihari Vajpayee is remembered for his people-centric policies and push for a transparent and accountable administration. To honour him and to take forward his legacy, his birth anniversary on December 25 is observed as the Good Governance Day every year



EPITOME OF GOOD GOVERNANCE

Former Prime Minister Atal Bihari Vajpayee, the statesman, poet, leader of the masses and the man loved by the people all across, left a void not to be filled forever on his death in 2018. On his 96th birth anniversary, one can say that the current Government is working on Vajpayeeji's legacies and taking measures to realise his dream of Swaraj to Suraj (self rule to good governance). The three-time Prime Minister has the credit of running the first non-Congress coalition Government in the country successfully for a full term following 'Coalition Dharma'. During his tenure as PM, the Government achieved significant milestones. Pokhran nuclear tests were conducted during his second regime and the Government led by Vajpayeeji withstood international sanctions. He never buckled under any pressure whether internal or external and emerged gracefully in situation like former Odisha CM Girdhar Gamang voting

against his Government. He lost the Government by one vote but won people's confidence. The term was also marked by his initiatives for peace with Pakistan and the Lahore declaration was signed.

With his Good Governance initiatives, Vajpayeeji took India to different levels. The Golden Quadrilateral Project, started by his Government, is shaping well in the present regime of the Narendra Modi Government. The visionary in him realised the potential of connectivity. Projects like mobile connectivity, roads across the villages of the country speaks volumes about the vision of the tallest statesman of the country. He was also responsible for India's mobile phone revolution as incoming calls were made free during his tenure.

It was under his rule that a new telecom policy was framed which offered great opportunities for private companies to expand. It was under his rule that India won the armed conflict with Pakistan that

took place between May and July 1999 in Kargil and elsewhere along the Line of Control (LOC). To make governance easy, three new states – Jharkhand, Uttarakhand and Chhattisgarh – were created by the Vajpayee Government. Inter-Linking of Rivers was the dream project of former Prime Minister Atal Bihari Vajpayee.

Good Governance means ensuring redressal of everyone's grievances; benefits and opportunities reaching every citizen; security for every Indian; that the Government reaches out to every citizens. For his legacy of good and people-centric decisions, he has been considered as the epitome of Good Governance. His aim was for a development-orientated, transparent and accountable government, which worked for early and easy deliverance of results to the public. He strived for all these throughout his tenure.

To honour him and to take his legacy forward, the Good Governance Day is celebrated on his birth anniversary every year. Soon after coming to power in 2014, Prime Minister Narendra Modi announced that December 25 will be celebrated as the Good Governance Day.

With 'citizen-first' being the mantra, motto and guiding principle, India is also aiming for bringing the Government closer to the citizens, so that the masses can become active participants in the process. The Government considers redressal of public grievances as a very important component of a responsive administration.

Since 2014, the redressal of public grievances has received the highest priority across all the Government offices. Also, there has been a lot of re-engineering. Ministries and Departments of the Government have been looking into their work spheres and their internal processes have improved a lot. Use of technology has also been promoted so that sitting at the comfort of their homes, people can connect with the Government. It has bridged the divide between the Government and citizens. On the first 'Good Governance Day' celebrations in 2014, the Prime Minister said an important step for Good Governance is simplification of procedures and processes in the Government so as to make the entire system transparent and faster.

"The push towards self-certification in place of affidavits and attestations is another indicator of the

- To implement the good and effective policies to complete a mission of good governance.

GOOD GOVERNANCE INDEX

On the Good Governance Day In 2019, 'Good Governance Index' (GGI) was launched. The Index has been scientifically designed on various parameters of governance. It is citizen-centric and would also seek to determine the status of governance as it exists today.

It is a uniform tool across states to assess the status of governance and impact of various interventions taken up by the State Governments and the Union Territories. The objectives of GGI are to provide quantifiable data to compare the state of governance in all states and UTs, enable states and UTs to formulate and implement suitable strategies for improving governance and shift to result-oriented approaches and administration.

Various principles have been kept in mind while selecting the indicators, i.e. it should be easy to understand and calculate, citizen-centric and result driven, leading to improved results and applicable to all states and UTs, among others.


These ten governance sectors are measured on a total 50 indicators. Difference indicators are given different weightage under one governance sector to calculate the value.

- **The slogan ‘Satyameva Jayate’ (Truth alone triumphs) is the legacy given to the nation by Malaviyaji, by saying that this slogan from *Mundakopanishad* should be the slogan for the nation**
- **He started the tradition of Ganga Aarti at Har Ki Pauri in Haridwar. He was dedicated to the cause of Hindi, Ganga and cow**

His vision shaped the foundation of Banaras Hindu University (BHU) in 1916. There was no match to Mahamana’s relentless efforts to accomplish any target, his steely resolve managed to get a large donation from Nizam of Hyderabad for BHU. It is said that on being denied donation to set up the university by the Nizam, he is said to have auctioned his slippers. Eventually, it was the Nizam who bid for them paying a huge sum. As president of

MAHATMA GANDHI

Indian National Congress for as many as four times and founder of Akhil Bharatiya Hindu Mahasabha, he never compromised with his principles. For Mahatma Gandhi, Mahamana was his conscience-keeper and like ‘his elder brother’.

In 1909, he founded an English newspaper – The Leader. It was published from Allahabad, now known as Prayagraj. As a lawyer, Malaviyaji is remembered for his defence of 170 people who got death sentence for Chauri Chaura incident in 1922. Around 155 of them were saved from the gallows while remaining persons’ death sentence was commuted into life imprisonment. He was opposed to the separate electorates for Muslims under the Lucknow Pact of 1916. Malaviyaji compelled the British government to sign an agreement with Ganga Mahasabha on uninterrupted flow of Ganga in Haridwar and protect Ganga for future obstructions. To honour the freedom fighter, Malaviyaji was conferred Bharat Ratna posthumously in 2015. ■

ON THE CUSP OF ENERGY REVOLUTION

When the entire world is facing the grave challenge of climate change, the need of the hour is to focus on renewable energy. Taking up the challenge, in the last six years, India has increased its installed renewable energy capacity to two-and-a-half times with more to come

India is constantly focusing on renewable energy since Prime Minister Narendra Modi took over reins in 2014. Inaugurating the third Global Renewable Energy Investment Meeting and Expo (RE-Invest 2020), the Prime Minister appreciated India's efforts in the field of renewable energy and environmental protection. While addressing representatives from over 80 countries, the Prime Minister expressed happiness over the progress from Megawatts to Gigawatts in generation capacity within a short span of time and 'One Sun, One World, One Grid' becoming a reality.

In the last 6 years, the



country has come a long way in terms of energy revolution. India is the 4th largest country in renewable power generation capacity and is growing at the fastest speed. The renewable energy capacity in India is currently 136 Giga Watts, which is about 36 per cent of the total capacity.

THE SUNSHINE SECTOR

- Out of the total power generation of 3,73,436

MW till October, 2020, the share of renewable energy is 89,636 MW. The Government has set the target of 175 GW by 2022 and 450 GW till 2030. (1 GW - 1000 MW - 1 Billion watts)

- States like Gujarat, MP, UP, Rajasthan, Tamil Nadu, and Himachal Pradesh will lead in renewable energy sector as they are more organised for solar revolution
- The Government's commitment towards other sources like wind, bio, hydroelectricity reiterates the fact that the country will meet the target by 2035



- Recently, an ultra Mega solar power project with a production capacity of 750 MW on 1500 hectares of land was launched in Rewa, Madhya Pradesh. This will help stopping emission of carbon dioxide which equals to plantation of 2.60 Crore trees
- India's initiative towards International Solar Alliance is a major landmark. As per National Solar Mission, focus is on manufacturing solar equipment that will help in making country self-reliant by 2030

PARIS AGREEMENT INDIA'S SUCCESS

The Paris Agreement of 2015 is crucial for checking the climate change and reducing its negative effects. As per the agreement, 179 countries of the world are committed to stop the temperature rise at 2 ° C or possibly 1.5 ° C during this century. According to the report of Climate Transparency, India is the only country among the G20 nations that has achieved the target set under the Paris Agreement. This shows India's consistent efforts towards renewable energy along with environmental protection. This reflects upon India's persistent efforts to create renewable energy sources and its commitment towards environment protection. ■

FLAGSHIP SCHEME: PM-KUSUM FOR A GREATER SOLAR MAP



Pradhan Mantri - Kisan Urja Suraksha Evam Utthaan Mahabhiyan (PM-KUSUM) is an important instrument towards connecting agriculture sector with modern technology. With the Government's core objective to bring prosperity in the lives of farmers, the Scheme aims to establish a new paradigm of success towards creating a strong solar map across the country in harnessing renewable energy resources.

India is a predominantly agrarian economy and farmers for long believed in irrigation methods depending upon use of conventional energy resources like electricity through thermal or hydro power. Lack of water for irrigation has always been a hindrance for a good yield over the years. With the goal of doubling farmers' income by 2022, the Government launched PM-KUSUM in February 2019, which was announced in the Union Budget of 2018-2019.

Crop damage is a recurrent problem due to erratic rainfall and lack of irrigation facilities. With PM-KUSUM scheme, farmers will be able to get irrigation facility by installing Solar pumps. They can also produce electricity by setting up solar panels in their fields and selling surplus to discoms. Uninterrupted power supply could be ensured in villages, which aims to install a total solar capacity of 25,750 MW by 2022. As per the target, three Crore irrigation pumps will be run by solar energy instead of electricity generated by other means by 2022. The Scheme will cost a total of Rs 1.40 Lakh Crore. Both the Centre and State Governments will contribute Rs 48,000 Crore each. Farmers will have to bear 10 per cent of the total cost of solar pump. About Rs 34,422 Crore for KUSUM scheme will be sanctioned through bank loans.

Two types of benefits from the KUSUM Scheme

The Scheme will benefit farmers in two ways. One, they will get free electricity for irrigation and secondly if they make additional electricity and send it to the grid, then they will also be able to earn some extra money

Power discoms may allow setting up of Solar or other renewable energy-based power plants of capacity less than 500 KW in specific cases.

COMPONENT B: Installation of 20 Lakh Solar-powered agricultural pumps. Individual farmers will be supported to install stand alone Solar agriculture pumps of capacity up to 7.5 horsepower (HP) for replacement of existing diesel agriculture pumps in off-grid areas. Pumps of capacity higher than 7.5 HP may be


COMPONENT C: Solarisation of 15 Lakh grids connected through Solar powered agricultural pumps. Individual farmers with grid-connected agriculture pumps will be supported.

DIESEL PUMPS TO BE REPLACED IN FIRST PHASE

The first phase of KUSUM Scheme envisages solarisation of only those pumps which are running on diesel. Arrangements will be made to run such 17.50 Lakh irrigation pumps with Solar energy. This will help curb diesel consumption, crude oil imports and ensure protection of environment. Farmer having barren land can use them to produce Solar energy. ■

EMPOWERING FARMERS

*Criticising the Opposition and countering those who spread confusions on the farmers' welfare, Prime Minister Narendra Modi said decades of deceit make farmers apprehensive but now there is no deceit, **“work is being done with intentions as pure as Gangajal”***



The Government is taking revolutionary measures for farmers and the farm sector. For decades, farmers were apprehensive about the promises made by the previous Governments. But now, the Government is taking steps and ensuring that rights of farmers are protected. They are getting more income and are also free from the compulsion of selling their products to any particular mandi. The Government is constantly trying to make the situation better for them. - New agriculture reforms have given farmers new options, legal protections and at the same time the old system also continues if someone chooses to stay with that
- Earlier, transactions outside the mandi were illegal but now a small farmer can take legal action on the transactions outside the mandi also.
- When you see the track record of the

present Government, the truth will come out automatically.

- Five years before 2014, pulses of around Rs 6.5 Crore were procured from farmers. But in the subsequent 5 years, pulses worth about Rs 49,000 Crore were procured, that is, about 75 times increase.
- In 5 years prior to 2014, paddy worth Rs 2 Lakh Crore were purchased. But in the subsequent 5 years, we have crossed Rs 5 Lakh Crore. That equals to almost two and a half times more money.
- The Government is spending crores of rupees to modernise mandis. Why would the Government spend so much if the mandis and the MSP were to be dismantled?
- Assistance is being provided directly to the bank accounts of more than 10 Crore farmer families of the country. So far, about Rs 1 lakh Crore have been reached to the farmers.
- The Government is also addressing the concerns of the families of farmers. The Prime Minister expressed confidence that those farmers who have some doubts on agricultural reforms today, will also take advantage of these agricultural reforms in future and can increase their income. ■

NEW FARM LAWS PROVIDING BIGGER MARKET, BETTER PRICES TO FARMERS

Empowerment of farmers has been the priority of the Government. The new farm laws passed by Parliament in September 2020 show the commitment of the Government towards doubling income of farmers by 2022

Transforming the agriculture sector in the country and raising farmers' incomes has been the priority of Prime Minister Narendra Modi since he took over reins in New Delhi. In the past six years, several measures have been taken to improve condition of farmers. The Government has the commitment of making income of farmers double by 2022. To provide multiple marketing channels and a legal framework for farmers to enter into pre-arranged contracts among other things, Parliament passed three new laws in September -- The Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act; The Farmers (Empowerment and Protection) Agreement of Price Assurance and Farm Services Act; and The Essential Commodities (Amendment) Act.



MSP INCREASED CONSIDERABLY DURING 2014-2020

- On recommendations of the National Commission of Farmers, headed by M S Swaminathan, the MSP for several agricultural products was enhanced by 1.5 times of the production cost incurred by the farmers
- On paddy, the Government hiked MSP by 2.4 times in the last five years. Actual payments made to farmers on paddy were a whopping Rs 4.95 Lakh Crore as against Rs 2.06 Lakh Crore in the previous five-year period
- On pulses, the increase in the MSP was the maximum at 75 times leading to a payment of Rs 49,000 Crore in last five years as against a meagre Rs 645 Crore made in 2009-14
- On wheat, MSP payment to farmers increased by 1.77 times during the last five years at Rs 2.97 Lakh Crore as against Rs 1.68 Lakh Crore in 2009-14
- On oil seeds and copra, the MSP witnessed an increase of ten times in five years. On both these products, the actual MSP pay out was Rs 25,000 Crore as against Rs 2,460 Crore given in 2009-14
- The Government agencies have made total procurement of foodgrains totalling 382 Lakh tonnes during Rabi season of 2020 which is an all-time record in itself



SPECIAL BOND WITH SIKHS

From opening up of the Kartarpur Corridor, stuck for decades, to celebrating the 550th birth anniversary of Shri Guru Nanak Devji on a grand scale worldwide, Prime Minister Narendra Modi and his Government have worked towards re-establishing the pride of the Sikh community. ECONOMY **on firm recovery path!**

Famed India growth story is set to return beginning next financial year on the back of firm recovery reported in the second quarter of 2020-21. Data suggests a V-shaped recovery in the economy


The worst ever pandemic has disrupted lives, jobs and economies globally and India is no exception to the cascading adverse impact of COVID-19. What perhaps stands out is the way Government, people and economy have responded in the last nine months.

A responsive Government, sensitivities of Indian people and economic resilience were on full display even as society devastated by the pandemic limped back to normalcy step by step and firmly at that. With the Central Government led by Prime Minister Narendra Modi rolling out an 'AatmaNirbhar' package to rescue the economy from onslaught of the pandemic and achieve self-reliance, most stakeholders responded beautifully and worked in unison to bring the mojo back in famed India growth story.

While this bounce-back was work in progress, several sectors showed promise and green-shoots in the economy were visible. Indian agriculture sector demonstrated its strength by growing at 3.4 per cent during the April–September 2020, i.e. last two quarters during the peak of spread in COVID-19.

Indian businesses have also responded positively to the policy packages announced by the Prime Minister beginning with the COVID-19 economic rescue measures initiated by the Government. In fact, this brought manufacturing growth into a positive zone at 0.6 per cent during July–September 2020 from the 39.3 per cent dip reported in the previous quarter.

Power, gas and water supply sectors have also grown by 4.4 per cent in the second quarter of this fiscal as against 7 per cent contraction reported for earlier three months i.e. in April–June 2020. Foreign Direct Investments (FDI) during April– September 2020 touched \$30 Billion, registering 15 per cent growth



- Manufacturing Purchasing Managers' Index (PMI) moderated to 56.3 in November against the decade high level of 58.9 in October. With PMI Services Index also ending the seven-month sequence of contraction to rise to 54.1 in October and 53.7 in November, growth of output in the second half of 2020-21 is poised to replicate the performance of Q2. Despite some moderations in November, Manufacturing sector is buoyant.



For the first time since February, GST collections both in October and November crossed Rs 1 Lakh Crore which is a major indicator of an increase in economic activity. Business activities have been restored after all restrictions have ended

According to the IMF, the economic package of Rs 29 Lakh 87 Thousand Crore given in three phases under the AatmaNirbhar Bharat Campaign supported the Indian economy. This package is 15% of India's GDP

over the same period last financial year. Healthy FDI inflows would give a big fillip to 'Make in India' for the world campaign call given from ramparts of Red Fort on August 15 this year. Evolving India as an industrial hub for the world is yet another project that's underway.


In continuation, it's rather encouraging to note that coal (11.6%), electricity (10.5%), fertilizers (6.3%) and cement (2.8%) sectors have posted healthy growth in October 2020 vis-à-vis performance in the same month a year ago. Various indicators like bumper harvest of Kharif crops, increase in the consumption of electricity, rail freight collections, swelling automobiles & two wheeler sales, better toll, GST mop up reaching pre-COVID period are signalling firm economic recovery.

The Manufacturing PMI in October was 58.9 and in November it was 56.3 which indicates decade's strongest recovery. The PMI of services sector too raised to 54.1 in October. In November,

it was at 53.7 which indicates strong recovery. Overall economic performance was better than expected given that the contraction was limited to 7.5 per cent in July-September 2020 as against 23.9 per cent in the previous quarter. Given that the economy was on a firm recovery mode, most independent consultancies have projected that the GDP contraction for the entire financial year would be much lower than earlier estimates.

Care Ratings, Nomura, ICRA, HDFC, IDFC First, QuantEco and Brickwork Ratings were some of the companies that ventured out to revise their earlier gloomy picture on the economic front. After the second quarter recovery, these ratings have estimated that the economic contraction would be much lower at 7-9 per cent as against earlier projection of 8.2-11 per cent.

Going forward most economists have estimated that the economic growth would be over 10 per cent 2021-22 which is very robust, putting India

- Total production of number of vehicles in all segments (two-wheeler, three wheeler and four wheeler) in October was at 2,830,153. The number stood at 2,086,479 in the corresponding month of the last fiscal

The automobile sector, troubled by very low sales during the lockdown, has recorded a sharp growth. The festive season in October has seen a rise in the number of vehicle sales

back on a high growth trajectory. Worse on the economic front due to COVID-19 seems to be over while the recovery leading to double digit growth in next few quarters seems to be on cards.

IMPROVED RATINGS BY MOODY'S, GOLDMAN SACHS AND BARCLAYS

During the Corona period, the growth rate of the economy reached a negative territory of -23.9 per cent. Experts predicted that in second quarter, the growth rate would be around -12% but proving them wrong, the economy stood firmly at -7.5%. The contribution of cement, steel, agriculture, manufacturing sectors played a crucial role in it. As per Monthly Economic Review of November 2020 of Department of Economic Affairs, Economy is now on a V-shaped recovery track. The Government's resolve resulted in the positive ratings by global economic agencies. Moody's has raised India's economic growth forecast for the year 2021 from


8.1% to 8.6%. Goldman Sachs and Barclays have also improved upon their forecasts. According to a report by Oxford Economics, Indian economy is recovering faster than expected. The International Monetary Fund (IMF) in its latest report on the world economic scenario has described India as the fastest growing economy. According to the IMF, growth rate of the Indian economy in the year 2021 will be at around 8.8 per cent, which will be the highest in the world.

A STRATEGIC VICTORY

Prime Minister Narendra Modi's strategy of taking challenges head on resulted in India becoming a country to tackle Corona satisfactorily in comparison to other countries. 


After the announcement by the Prime Minister, Union Finance Minister Nirmala Sitharaman





I am cautiously optimistic as data is showing a good economic recovery

From *Jaan Hai* to *Jahan Hai* to *Jaan Bhi Aur Jahan Bhi*, India has come a long way from not only saving lives but also bringing the economy on track. The country with 137 Crore population is not only faring better in terms of dealing with COVID-19 pandemic onslaught but also its impact on the economy. The upturn in the economy is visible by various indicators which has been made possible due to proper planning, better execution and a decisive leadership. In an exclusive conversation, Chief Economic Adviser **Dr K V Subramanian** spoke to Consulting Editors of **New India Samachar Vinod Kumar** and **Santosh Kumar** on various issues including future roadmap of the economy. Excerpts:



Q India's preparation to check COVID-19 pandemic not only saved lives but also gave a new impetus to the economy. How did the Government's plan work effectively, which is taking the country towards a new hope?

A When cases of COVID-19 started increasing in other countries around March, we studied the pattern of Spanish Flu pandemic that struck around 102 years ago. The one thing that came

out of it was that countries where lockdown was implemented properly with lesser mortality rate, the economic recovery was much better. The inference came out from this that we have to chalk out a long-term strategy. The Government's priority was to save lives first and then to take care of the GDP. The Prime Minister said it correctly, '*Jaan Hai to Jahan Hai*'. After people followed his words and the nation was recovering fast, the slogan of '*Jaan Bhi aur Jahan Bhi*' made an impact with the gradual

Q What is the significance of \$5 Trillion economy that the Prime Minister is aiming for? How can one contribute to it?

A I think lots of reforms introduced are intended to achieve that growth. For citizens, it is essential to follow simple rules especially with respect to COVID-19. Make sure to wear mask, maintain social distancing and wash the hands frequently. The economic impact is quite related to pandemic itself.

phases of unlock. The GDP of UK went down to 20 per cent while India's GDP went down to 23.9 per cent despite more stringent lockdown in India. Now, things are looking up in the unlock phase as manufacturing sector is showing a greater recovery. We can see a V shape recovery.

Q Industry and other sectors appreciated economic reforms and resolve of Prime Minister Narendra Modi to put the country on growth path. What are the reasons for this?

A The economic crisis in the aftermath of COVID-19 pandemic is quite different from earlier crisis. It created a negative growth rate for demand, which potentially impacted the long-term economic growth. To ensure that it didn't happen, the Government undertook a series of reforms. The labour reform, agriculture reform, definitional changes of MSME and the PLI scheme, all these are very seminal because they are doing two things primarily. First, they are enabling the economy to become much more formalised. For instance, if we compare job data of 2011-12 with data of 2017-18, it shows a five per cent reduction in the proportion of casual workers with five per cent increase in the proportion of salaried workers which is an indication of formalisation of economy. Second part was also to concentrate on making growth in job sector more intensive because if you look at sectors like agriculture, manufacturing, they account for large proportion of employment in the economy.

Q Post demonetisation, the economy is moving fast towards digital and cashless medium laying foundation of a strong New India. What was the

Government's perspective behind such a bold decision?

A Digitisation of economy enables it to become more firm and activates formal sector. With JAM (Jan Dhan, Aadhar and Mobile), a trinity is created. I think the COVID-19 crisis also demonstrated that lots of activities are making a significant push towards digitisation.

Q BHIM App is completing four years and the period has remarkably shown a major shift towards digital transactions, especially in times of Corona. What is the roadmap ahead ?

A In India, money got transferred to bank accounts of needy people under various schemes of the Government just by one click. People are doing digital transactions by sitting at home following social distancing. It helped a lot during pandemic.

Q Economy is a complex term for a commoner. How is the size and behaviour of the economy different from other countries? How can a common man for whom technical jargons of economy are not relevant, can understand its benefit in easy words?

A As we explained in this year's Economic Survey that talks about *Thalinomics*. Inflation can be understood with the rate of increase in prices of a plate of meal. Similarly, when we talk about employment, it talks about the number of people getting jobs. Similarly, GDP growth is calculated in terms of activities of people and income generated from them. The analysis is based on the basis of percentage increase or decrease. These are two-three crucial data that is important for analysing micro economics.

Q How is Prime Minister's AatmaNirbhar Bharat campaign proving to be helpful for the economy?

A There are some important aspects. First, we have become self-reliant in various sectors. We have become the second largest producer in the world in PPE kits production. It is important to understand that self-reliance comes with competence. No person, company or the country can become self-reliant if, they are not competent. Secondly, if you see the kind of product and services provided by

Q The Prime Minister always talks about opportunity in the crisis. How do you look at India being an economic superpower?

A This pandemic has proved that vision of India is farsighted. We don't visualise from one quarter to another quarter. There was certain impact on the economic activity due to lockdown as lives must be saved first. If we look at the death rate, India has 5 deaths per lakh while the US has 60 deaths per lakh. Death rates of Spain, Italy, UK is 10 to 12 times higher than India. This long-term vision will take India a long way. India can be the example of ethical wealth creation. As per a report, India was the world leader in economy for seventeen and a half centuries. India's contribution to the world GDP was one third (33 per cent) of the total global GDP. On the other hand, the USA, which is considered to be the economic superpower has only 15-16 per cent contribution to the world GDP!

our companies, they make products for top 20 to 30 per cent lot on the income pyramid. But certain sectors like FMCG has products for people even in the remote areas of the country like shampoo sachet. We are trying that companies should give products and services to widen their consumer base as one of the biggest strength of India is that we are a country of 137 Billion people.

Q Reports of IMF, World Economic Forum and Moody's ratings have signalled a major improvement in the economy during pandemic. How one can understand this with the help of these indicators?

A We have discussed that during the unlock phase, the recovery is very well and that is what is being reflected in ratings of these agencies. I do think that many a times lots of analysts' researches end up taking into the account the recent data and often

ignore the long-term trend. But these ratings are definitely a good news.

Q The IMF has said in its report that by 2040 India's contribution to the world's growth rate will be one third. How do you look at it?

A I think policies and reforms will provide the necessary growth impetus to the Indian economy and we will surely realise this prediction.

Q Corona is not yet vanished. Reforms are continuing. Will the growth accelerate or is there any possibility of it falling again?

A I am cautiously optimistic as data is showing a good economic recovery. But since this is winter season and in this weather such cases increase particularly in North India, so this is my appeal to people to remain more cautious so that cases don't increase. This is not only in the interest of individual but also in the interest of the country.

Q When will we be able to reach the positive territory of the GDP?

A This is my presumption that in Q3 or Q4, we will be able to reach that mark.

Q It is agriculture sector that remains unaffected from the negative growth rate. Creating opportunities in agriculture sector has always been a concern. The Government has made an announcement of creating an Agriculture Infrastructure Fund of Rs 1 Lakh Crore. How is it going to help the end-users, our farmers?

A Agriculture sector is not much affected as social distancing is not a matter of concern for the sector. The Government has taken all necessary measures despite lockdown. The agriculture sector has provided a cushion. The recent reforms particularly Farmers' Law are very important for agriculture sector because small farmers will be able to sell their produce to anyone. Moreover, there are around 40 to 45 per cent people working in the sector which has a huge potential of job creation. The required growth will not be possible without proper infrastructure. The investment will happen due to Rs 1 Lakh Crore infrastructure fund. Infrastructure fund is likely to work for the growth of agriculture sector. ■



EIGHT BUNGALOWS REDEVELOPED TO BUILD 76 FLATS FOR MPs

Accommodation for the newly elected Members of Parliament in Delhi has been a long-standing problem. The MPs have to put up in hotels for a long time and this leads to financial burden on the Government. Even the MPs did not enjoy this, but were under compulsion. After 2014, serious efforts have been made to overcome this problem

At the Dr B D Road in Delhi, close to Parliament, more than 80-year-old eight bungalows were redeveloped into 76 flats. Keeping in mind the protection of the environment, these flats have energy conservation measures, solar and sewage treatment plants. Bricks used in the building are made from fly ash. The building has double glazed windows for thermal insulation. Energy efficient LED light fittings, occupancy-based sensors for light control, air conditioners with VRV system for low power consumption, low flow fixtures for conservation of water, rainwater harvesting system and rooftop solar plant were also installed in the building.

Construction of these flats has been completed with savings of about 14 per cent from the sanctioned cost and without time overrun despite the impact of COVID-19. Prime Minister Narendra Modi inaugurated these flats on November 23, 2020.



The mask is specially prepared for healthcare, sanitation workers and others. Workers are getting employment and learning new techniques. Sportspersons preparing for the next year's Olympics are using these masks so they are not only protected from Corona virus but also get the right environment for preparations.
